

CAVEATS ON OCCUPATIONS

Essentially, caveats are additional visa restrictions imposed on certain occupations by Immigration. Caveats apply to the following visa programs:

- Temporary Skill Shortage (TSS) visa (subclass 482)
- Employer Nominated Scheme visa (subclass 186) Direct Entry Stream

This means an occupation cannot be nominated by an employer if its caveats (if any) are not satisfied.

A summary of the caveats that apply to particular occupations is provided below.
